(i) Irricana Library Board, 2015 Budget Proposal

Bob Anderson presented on behalf of the Library Board.

The Alberta Libraries Act requirements for budget presentation and approval was referenced as the requirement for the presentation.

Highlights of the budget include:

- Deficit budget before reserve transfers for 2015 including consolidation of asset purchases of approximately \$80,000 resulting in an operating loss of only \$6054.
- Deficit will be covered by
 - o \$63,000: Lions (40k) and Gladys Taylor fund (\$40)
 - o reset from reserves
- Capital expenditures relate to the new building expansion.
- Requisition from the town will be the same as 2014.

Other changes from 2014 include minor items such as a small gain in programming, book purchases (\$600 to \$1000), payroll (increase of approximately \$3000).

New additions include library 30th anniversary celebrations and plan of service (\$500) to start the process which is required in subsequent years.

 =>The Gala, but we have in past.
- Deputy Mayor Tracz: added the rational for the big expenditures is the capital requirements of the new building.

It was added the Library is applying for another grant in the 2015 year for improving community facilities. Clarification on status of the Library versus a charitable organization (Friends of the Library) for charitable donations.
