Presentation by CAO provided an outline of the inquiry from Municipal Affairs into errors in educational tax requisitions. It was also explained the Staff then reviewed the entire process in terms of possible errors that were found dating back to 2011.

As per our TAX CLERK: no supplemental billing in 2013

An outline of taxes levied annually per bylaw, the taxes collected as well as explicit examples from the 2014 bylaw where \$1,079,891 was to be raised by taxes and in \$1,050,160 was part of the tax rate calculation with the balance for minimum tax charges. The CAO explained issues from past years would be beyond the appeal period to have re-billed.

The example was extended to show in 2013 \$1,007,637.18 was raised by taxation and \$1,007,638 was used in the tax rates but not taking into account the minimum tax administrative charge. In each case there was a discovery of a lack of supplemental taxes and the overage was a result of the minimum charge not being disclosed or counted in the calculation.

A summary was presented showing figures from the audited financial statements and submitted reports to municipal affairs. In the years 2011 through 2013 the over charges were spread evenly amongst the properties however in 2014 the amount was not applied evenly.

The CAO also reviewed errors in the education taxes as per 2011 and 2014 which resulted in overpayments for those supporting public education and an underpayment for those supporting the separate school board. Issues such as ethics, policy and training were provided.

Summaries of amounts owing were presented showing the 2014 discrepancy including over 400 properties were averaging an \$11 refund but some properties were in extreme situations of \$250 owing or two properties owed refunds of over \$500.

Recommendations on collections and billing were presented to write off small amounts (Under \$2), add items to the current bills but stop interest for those not in arrears and issue refunds for those with a net impact of over \$50 overpaid.

Questions from Council:

Councillor Laura Thiessen: questioned regarding amounts charged and information and disclosure. Deputy Mayor Dennis Tracz: questioned the status of controls.

The CAO relayed the offer from Municipal Affairs to review the bylaw each year, however training and strengthened controls are needed. The CAO also added while the amounts are fully disclosed but not reported in one area, overall the taxes need to be reconciled prior to billing.
