# **Chief Administrative Officer Report Review of July 18 to August 13, 2018**

#### **Public Works:**

• Public Works shop renovations: Bay doors are being framed in for the new door installation. PW has been painting the hallway, and put in a concrete ramp into the new small bay door opening on the south side.

#### Water/Sewer:

- A Hydrant isolation valve at the North end of Pioneer Drive has been repaired and the Ice Rink Hydrant isolation valve has also been repaired.
- The Water usage in the heat has been huge over the summer.
- Waiting to get a schedule for the 1<sup>st</sup> street & 1<sup>st</sup> avenue storm line repair.

#### **Roadways/Sidewalks:**

• We still have Line painting and crack filling to do on the roadways.

#### Parks & Recreation:

- The ramp into the Skating Rink has been paved.
- The old cable fencing has been removed at the Splash Park and a new black coated chain link fence has been installed. Looks great.
- Picnic tables and benches are being stained/painted by the PW Summer Students. This will be on-going over the next few weeks. Three bleachers for ball diamonds are also being repaired/stained.
- The Cemetery entrance fence has been stained.

#### **Town Buildings:**

- The roof at the Library has been repaired.
- The C-can at the Community Hall has been emptied out of the PW water works stock (Can now be used for Hall storage).

#### **Community Facilities:**

- Applied for ICIP grant for \$676,468 for Recreation Centre Upgrades
- Applied for Community Grant for \$50,000 for new playground at Splash Park

#### **Community Services**

- CSB Next meeting scheduled for August 28<sup>th</sup> at the Town office at 6:00pm
- Final Fall Fair meeting scheduled for August 13<sup>th</sup> @ 7pm at the Town Office.
- Women's Conference plans have been finalized for October 13<sup>th</sup> 2018, promotions will start this week
- Received MSI funding for Rainbow Park upgrades, scheduled to be completed by the end of September
