**BYLAW 001:2019  
of the TOWN OF IRRICANA  
in the PROVINCE OF ALBERTA**

**A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF IRRICANA FOR THE 2019 TAXATION YEAR.**

**WHEREAS**, the Town of Irricana has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meetings held on May 13th, 2019; and

**WHEREAS**, the estimated municipal expenditures and transfers in the budget for the Town of Irricana for 2019 total \$1,952,230; and

**WHEREAS**, the estimated municipal revenues and transfers from all sources other than taxation for the Town of Irricana is estimated at \$884,477 and the balance of \$1,067,753 is to be raised by general municipal taxation; and

**WHEREAS**, the requisitions are:

**WHEREAS**, the Council of the Town of Irricana is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

**WHEREAS**, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2018; and

**WHEREAS**, the assessed value of all property in the Town of Irricana as shown on the assessment roll is:

<b>Residential &amp; Farmland</b>	<b>\$120,579,690</b>
<b>Non-Residential</b>	<b>\$ 6,638,750</b>
<b>Total</b>	<b>\$137,093,670</b>

**NOW THEREFORE** under the authority of the Municipal Government Act, the Council of the Town of Irricana, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town of Irricana:

2. The minimum amount payable as property tax for general municipal purposes shall be \$500.00 per parcel.

3. That this bylaw shall take effect on the date of the third and final reading.
