

BYLAW #6:2008

**A BYLAW OF THE TOWN OF IRRICANA IN THE PROVINCE OF ALBERTA
TO AMEND BYLAW #14:2003 TO REGULATE, LICENSE AND ALLOW THE
TRAPPING OF CATS**

WHEREAS the *Municipal Government Act*, RSA 2000, c.M.26 provides for the regulating of domestic animals; the Council of the Town of Irricana, in the Province of Alberta, duly assembled, enacts as follows:

WHEREAS the Council deems it necessary to provide for the fair and efficient regulation, licensing and trapping of cats occurring within the Town of Irricana; and

WHEREAS the Council deems it necessary to amend Bylaw No. 14:2003, the existing "Cat Bylaw"; and

NOW, THEREFORE, THE COUNCIL OF THE TOWN OF IRRICANA, DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:

1. That Section 7, Subsection 17) of Bylaw No. 14:2003 be deleted:

2. That Section 7, Subsection 18) of Bylaw No. 14:2003 be amended to:

To assist in the seizure or capture of cats, the Town may utilize live traps. Said traps shall be used in a humane manner. Should the animal be hurt during capture or attempted capture neither the Town of Irricana, Council, nor the designated officer shall be held liable for such injury.

3. That Section 7, Subsection 20) of Bylaw No. 14:2003 be amended to:

When a cat is trapped, the resident must deliver it to the Town Office as soon as possible within the hours of 8:30 am to 4:30 pm Monday to Friday.

4. That Section 7, Subsection 21) of Bylaw No. 14:2003 be amended to:

Any cat impounded shall be kept at a Town facility or at a humane facility contracted by the Town of Irricana and held in controlled confinement for:

- a. a period of five(5) days; in the name and address of the owner is known
- b. a period of seventy two (72) hours, if the name and address of an owner is unknown
- c. for a longer period than provided for in subsection 21a or 21b if, in the opinion of the Town, the circumstances warrant a longer impoundment period.

5. This Bylaw amending Bylaw No. 14:2003 shall come into force and effect upon the date of its Third and Final Reading.


