This policy ensures that all unbudgeted expenditures require an appropriate level of approval prior to being made.

The accepted MSI Grant funding for this project was \$82,449. To date for this portion of the project we have expenditures of \$88,389. In order to complete the siding (\$2,215) and add replacement flooring for the ECS room (\$11,888) and Playschool (\$12,391) room the town can amend the MSI grant funds required. In June 2022 a significant rain revealed repairs needed to the roof to prevent further water damage to the roof, the interior ceilings, and floors. An emergency repair was required immediately and completed by Benjamin Moore Rocky View Services for \$11,000.00. The second repair is required to repair the curling rink ceiling quoted at \$7,125.00. The flooring in the Boys and Girls Club is in need of replacement and that quote is \$11,891

# To all concerned Parties – Town of Irricana, Alberta TrailNet, Rockyview County

First, I will introduce myself. My name is Bob Swanson, and I am the President of Pioneer Acres of Alberta.

I am writing this letter to address concerns that Pioneer Acres has been aware of since I became President in February of 2022. I would like to have questions answered about these concerns as they do affect all parties I am contacting.

There seems to be a certain amount of animosity between Pioneer Acres, the Town of Irricana, Rockyview County staff and Alberta TrailNet that has been there for a long time and no one at Pioneer Acres seems to understand why. I have asked several people that know the area better than I do, and they all feel the same, why is this, what did Pioneer Acres ever do to deserve this kind of treatment?

I will try to explain all the events that have led up to me writing this letter.

The first that I was aware of any problems was when I got a call from Russel Friend of Newcan Fencing who was doing some work for Alberta TrailNet; his concern was that the approach to the property that Pioneer Acres owns east of the Alberta TrailNet was removed and people were driving in on the fresh made trail and were going to destroy it. He said I should contact the Town and have them put our approach back in so people would use it instead of the trail. He also said he was to put up a barbed wire fence to divide the two properties but had refused because it was supposed to be a chain link fence.

At this point Gary Gibson, our Past President, and I went down to look at what was going on. Yes, we did see that the approach had been removed and also that the crews working for Alberta TrailNet had entered the Trail through our property by cutting our fence and driving through the ditch. At this point we had never had any contact with Alberta TrailNet as to their actions. I did however hear from one of the Town's crew that he had called Bob Anderson and

let him know but was not sure when this all happened. The crew member only told me he had done this in August.

Gary Gibson and I went to the Town office to see Barrie, but he was not available, and we had a difficult time to contact him most of the summer. I'm not disputing the removal of the approach as it was on the Alberta TrailNet property, but I thought it would be common courtesy to let us know their intentions.

At some point one of our members, I don't know who it was, contacted the County and asked them about putting in a new approach but was told that the Town controlled the road going by Pioneer Acres and we would have to talk to them. This was confirmed by one of our members in a conversation with Barrie. On April 7, I was copied on an email from Barrie to a Linda Strong-Watson, and had no idea who this person was, saying what the Town intended to do about an approach to our property along with a map showing the plan. This plan came from Gregory Perrault, Road Operations Technologist and says the Town will put the approach to our property off of their property on the SE corner of our property because for some reason it conflicts with the Trail where it was. It has also been revealed to us that the Town, in fact, does not control this road and that it is a county-controlled road.

Question: Why is a county employee giving out misinformation?

Question: What involvement does the Town have with Alberta TrailNet to provide Pioneer Acres with an approach?

Question: Why is Alberta TrailNet not responding to any of these issues. I have never had any contact with any of their representatives to date.

As the Town started to proceed with their plan to put in the approach, our membership started having many concerns with what they were seeing and told me this was not going to work the way it was shaping up. At this point I sent Barrie an email expressing our concerns and he said the Town had gone too far at this point and there were no other options other than going through the MD. On a phone call later, he said this involved a lot of surveying and planning and would take a lot of time to get it done. He said they would remove one tree and put in a longer culvert and more fill. Some of our membership wanted to just go ahead and put in our own approach at this point but I did not want to do this without it being approved by the County. Two wrongs don't make a right.

Again, I ask, why is the Town even involved in this? As time was short before our Annual Show, we decided our only option was to try and use what the Town had put in and fortunately the County did offer some assistance with some gravel and equipment to make it work. We were thankful that it did work out okay and we were able to get our campers in and out without too many issues. I do say thanks for all that the Town and the County did to make this possible.

Unfortunately, we still have some concerns about having an approach that comes in off of someone else's property. Do we need to have a caveat on it against the Town? What about insurance to cover any type of claims in case of an incident and not sure what else needs to be in place? With this in light our board has approved a motion to apply for our own approach off of RR 27.4 and will be applying to the County for this. We do understand that it is our right to have access to our own property from a County road. We have not decided where, at this point, but it will be close to where our old approach was.

#### Hello Bob

There are two organizations involved in the development of the Meadowlark Trail. Alberta TrailNet Society (TrailNet) is a not for profit charitable organization dedicated to promoting the development and responsible use of recreational trails. TrailNet owns the former CP Rail right of way lands that pass by Pioneer Acres property. TrailNet works in partnership with the Meadowlark Trail Society, the local trail group that is assisting with developing and operating the trail on these lands. Jeannette Richter is their representative.

You have raised several issues in your letter of September 12, 2022, which we would like to respond to. The first of these is an apparent history of poor communication and relationships. Alberta TrailNet has requested to meet and present to the Board of Pioneer Acres several times in the past but has never been provided that opportunity. Jeannette Richter of Meadowlark Trail Society has however attended one of your board meetings prior to the development permit application with the County and would be happy to do so again. She has also been in contact with past-president Gary Gibson many times over the years to inform him of TrailNet's and Meadowlark Trail Society's plans. That communication lapsed somewhat when Gary was not available prior to your election as president. It was only recently that we were informed of and able to obtain your contact information as Pioneer Acres' newly elected president.

The second issue raised is that of chain link fencing. There has never been a proposal or a requirement for a chain link fence to demarcate TrailNet property and Pioneer Acres property. The trail development plans, submitted with the development permit application and shared at local public meetings, have always indicated that there would be post and wire fence running along TrailNet's east property line. This was approved in the Direct Control bylaw which is available through the Rocky View County website.

The third issue is that of removal of Pioneer Acres former road access. The approach that Pioneer Acres had developed and used in the past was located on Alberta TrailNet

property. The new Trail approach required a culvert to facilitate drainage. The old Pioneer Acres approach did not include a culvert and was down slope of the trail approach. Last December, prior to the trail construction crew pulling their equipment out for the winter, TrailNet had to make an immediate decision regarding removal of the old Pioneer Acres approach to avoid water build up and spring flooding in the area. There was a series of emails between Pioneer Acres, the County, TrailNet and the Town of Irricana at the time. The County contacted TrailNet's consultant indicating that, as the area was within Irricana's municipal boundary, it would require Irricana's attention to help resolve the matter. The County requested that TrailNet contact Irricana regarding removal of the old access and Pioneer Acres concern and need for an alternate access solution. Irricana's CAO promptly investigated and contacted Pioneer Acres and Rocky View County to indicate what the Town would provide by way of a new approach. From your letter it appears that both the Town and County have since assisted with additional improvements to the new access to Pioneer Acres parking.

Parking is not permitted along TWP Rd 274. Trail parking is located at the established trailheads in Beiseker and Irricana (Irricana trailhead is located on RR263A south of the furthest residence on the way south out of Irricana). We hope to put in a permanent washroom here in the near future for Trail users. If needed, additional signage indicating where the trail parking is located can be provided.

We have always seen Meadowlark Trail and Pioneer Acres as local partners in the future. We heard that one of your young volunteers walked home to Beiseker on the Meadowlark Trail after working her shift during Pioneer Acres Days. People attracted to your events will have the added amenity of a lovely trail to walk and cycle on safely with their young families, and trail users will have the opportunity to discover and learn about Alberta's agricultural history by visiting Pioneer Acres Museum and events.

In conclusion, we appreciate hearing of your concerns and hope that this info provides some clarity regarding these issues and that a more collegial relationship and improved communications can be achieved between our organizations. We would welcome the opportunity to meet with you.

Dear Minister Shandro:

I am writing in response to your August 26, 2022 letter to Her Worship Debra Dueck, Mayor of the Town of Tofield regarding the recently announced changes to victim services. Alberta Municipalities greatly appreciates your reversing the changes to the Victims of Crime fund and benefits program that were introduced in 2020 and expanding both eligibility and benefit amounts. However, I would like to clarify your statement that Alberta Municipalities was engaged on and was consulted on the new zonal governance model as proposed by the provincial government.

Alberta Municipalities administration did attend a two-hour virtual engagement on November 9, 2020, where, along with other discussion materials, three test concepts for service delivery and governance were presented. However, these test concepts were not discussed in detail, nor was there any mention of changes to service delivery that would require caseworkers and administrative staff to reapply for their positions. Accordingly, I can confidently confirm that Alberta Municipalities was not consulted, nor provided the ability to give feedback on behalf of its member municipalities, regarding the proposed delivery specifics of victim services. During this discussion and as a more general statement, Alberta Municipalities only noted the importance of ensuring sustainable funding and equitable access to victim services for all Albertans, regardless of the service delivery and governance model.

I look forward to the upcoming engagement on this important topic and working with you to preserve and enhance the supports and services available to victims of crime across Alberta.

Dear Mayor/Reeve:

The Government of Alberta is recognizing and endorsing the following International Holocaust Remembrance Alliance working definition of anti-Semitism through an order-in-council.

"Anti-Semitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of anti-Semitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."

Thirty-five countries, including Canada in 2019, endorsed or adopted this definition. Along with Alberta, three other provinces: Ontario (2020), Québec (2021) and New Brunswick (2021) have already endorsed or adopted the definition.

The Alberta Human Rights Act prohibits discrimination on the basis of several categories, including race, religious beliefs, colour, ancestry, and place of origin.

All forms of racism are unacceptable, and endorsing this definition is just one way Alberta's government is combating racism, supporting racialized communities, and promoting a safe and welcoming province for everyone.

The Government of Alberta is asking all municipalities across Alberta to consider accepting and amending their bylaws to reflect this definition.
